RECTOR'S DIRECTIVE NO. 12/2021**TUITION FEES AND STUDY-RELATED FEES
IN THE ACADEMIC YEAR 2022/2023**

In accordance with the provision specified in Sections 92, 113a, 113aca and 113af of Act No. 131/2002 Coll. on higher education institutions and on the amendment of certain acts, as amended, the provision specified in Section 12 of the Statute of the Technical University of Košice, and in accordance with Resolution No. 40/2021 of the meeting of the Academic Senate of the Technical University of Košice held on 11 October 2021, which approved the amount of tuition fee and study-related fees, I hereby

i s s u e

1. **the amount of tuition fees** for the study programs that will be provided by the Technical University of Kosice and its faculties - Faculty of Mining, Ecology, Process Control and Geotechnologies (FBERG), Faculty of Materials, Metallurgy and Recycling (FMMR), Faculty of Mechanical Engineering (SjF), Faculty of Electrical Engineering and Informatics (FEI), Faculty of Civil Engineering (SvF), Faculty of Manufacturing Technologies (FVT), Faculty of Economics (EkF), Faculty of Arts (FU) and Faculty of Aeronautics (LF) (hereinafter referred to in abbreviated forms of names for the given faculties),
2. **the amount of study-related fees** at the Technical University of Košice and its faculties,
3. **the payment method and the due date** for tuition and study-related fees

in the academic year 2022/2023 as follows:

I.**Basic provisions**

1. Annual tuition fee according to Section 92 par. 1-8, Section 113a par.10, Sections 113aca, 113af **and Section 113am par. 15** of Act No. 131/2002 Coll. on higher education institutions and on the amendment of certain acts, as amended (hereinafter "the Act") is to be paid by the students of the Technical University of Košice (hereinafter referred to as "TUKE"), who
 - a) are concurrently enrolled in two or more study programs at the same level of study (Section 92 par. 5 of the Act), one of which is studied at another university free of charge according to Section 70 par. 1k of the Act,
 - b) are concurrently enrolled at TUKE in two or more study programs at the same level of study (Section 92 par. 5 of the Act),
 - c) study the study program beyond the standard length of study. **Tuition fees due to longer studies than the standard study length of the relevant study program shall be determined as a proportion of the annual tuition fee depending on the number of credits to be obtained by the student in the relevant academic year in relation to the standard student load.** (Section 92 par. 6 and Section 113a par.10 of the Act),
 - d) if the study program is studied beyond the standard length of study for the purposes of participation in the academic mobility in the framework of an exchange program in compliance with the terms of this exchange program, or if the student has been provided a social scholarship in his/her final year of study in a respective study program of the standard length, there is no obligation to pay the tuition fee for the upcoming year of study, which follows after exceeding the standard length of study (Section 92 par. 6),
 - e) are enrolled in a part-time study (Section 92 par. 3, Section 113af of the Act) unless they have been admitted to a free study program according to Section 113aca of the Act,
 - f) are enrolled in the study program entirely in a language other than the official language (Section 92 par. **8 and Section 113am par. 15** of the Act) or a minority language (Section 92 par. 9 of the Act), if it is possible in Slovakia to study such study program also in the official language. **The obligation to pay tuition fees shall arise only if:**

- **in the academic year in which the student began studying the relevant study program, a public higher education institution admitted students to study in the same field and degree of study in the study program, which is also conducted in the state language, and**
 - **the university informed the admitted applicant in writing about the obligation to pay the tuition fee along with the annual tuition fee amount for all years of study during the standard study length of the study program.**
2. If it concerns the students under inter-state agreements, tuition and study-related fees are governed by the provisions of these agreements. **If an inter-state agreement or an international agreement does not regulate the conditions for the payment of tuition fees or if tuition fees are paid in accordance with the regulations of the admitting state, the obligation to pay tuition fees does not arise if the student is granted a scholarship from the state budget funds. A student who is granted a scholarship from a scholarship program created with the government consent and a student who studies in the Slovak Republic as a part of academic mobility pursuant to Section 58a of the Act, through an exchange program created with the government consent or under the European Union program for education and training, youth and sport, or a student who has been granted asylum, temporary shelter or additional protection, is not obliged to pay tuition fees.** (Section 92 par. 11 of the Act).
 3. Each student and successful applicant at TUKE is obliged to pay the required annual tuition fee before the enrollment or before the end of online enrollment for the respective academic year.
 4. In justified cases (according to the Methodological Guidelines on the Reduction, Remission, Postponement of the Due Date or Repayment of Tuition Fees, which forms Annex of no. 27 OS Education), the student may ask the Rector for the reduction, remission, postponement of the due date or repayment of tuition fees. This does not apply to the students studying in a foreign language. Specific cases are dealt with by the relevant faculty.
 5. The payment of tuition fees shall be done by bank transfer to the faculty bank account.
 6. The applicant for the study at TUKE is obliged to pay a fee for admission procedure according to Section 92 par. 12 of the Act within the prescribed period and in a manner to be determined and published by the faculty (Section 57 par. 5 of the Act). In a case of failed or incomplete admission procedure, the fee for admission procedure shall not be returned to the applicants for the study at TUKE.
 7. TUKE students are obliged to pay study-related fees pursuant to Section 92 par. 13-15 of the Act within the prescribed period and in a manner to be determined by TUKE, or its relevant faculty.
 8. In accordance with Section 92 par. 18 of the Act and Section 12 par. 7 of the Statute of the Technical University of Košice, the Rector may reduce, remit tuition and study-related fees or postpone their due dates at the written request of the student in the case of:
 - a) a student in a difficult social situation,
 - b) a student with special needs and health problems,
 - c) a student with excellent academic results,
 - d) another fact worthy of special consideration.

Consideration of given applications shall be governed by the Methodological Guidelines on the Reduction, Remission, Postponement of the Due Date or Repayment of Tuition Fees, which supplement and explain the provisions of Section 12 par. 7 of the Statute of the Technical University of Košice, which forms Annex of no. 27 OS Education.

9. If a TUKE student decides to apply for a reduction, remission, refund, or postponement of the due date of the tuition fees payment, he/ she shall do so until **7 October**. The deans shall submit applications to the Rector for a decision by **15 October**.

II. Tuition fees

1. Students are required to pay the annual tuition fee for:

a) enrollment in a second and another study program in the concurrent study (Section 92 par. 5 of the Act) in the Slovak language
